ENERGY, ENVIRONMENT AND RENEWABLES

This session will start with the role of Caspian hydrocarbons history and its role in global energy developments and then focus on the country's transition towards achieving sustainable development in line with its climate change adaptation and mitigation measures. We will examine the transformation of the global energy system through the lens of sustainable development and climate change. The session will also study how the global climate change might impact the Caspian region and Azerbaijan in particular.

ECONOMICS OF ENERGY

The session will analyze the determinants of energy prices as well as their economic impact on both local and global markets. It will investigate the economics of the upstream, midstream, and downstream segments of the oil and gas industry, providing a comprehensive understanding of how each segment contributes to overall energy pricing dynamics. Participants will explore various factors that influence energy prices, including supply and demand fluctuations, geopolitical events, regulatory frameworks, and technological advancements.

GEOPOLITICS OF ENERGY

The session will examine the use of energy resources to promote political and security goals and peace. Particularly, it will discuss whether there is an "oil weapon" and a "natural gas weapon". The sessions will look at the conditions under which supply relationships are vulnerable to political use. It will also study the attempts to use energy infrastructures as tools for conflict resolution, including the so-called "peace pipelines."

ENERGY LAW AND DIPLOMACY

The session will focus on energy law and diplomacy as a foreign policy instrument and safeguard of economic and energy security. It also impacts the energy contracts that play a major role in energy exploration and production. The session will examine energy diplomacy and its role in the legal framework in the energy industry.
